### THE ORGANIZATION

The 2° Investing Initiative [2°ii] is the leading think tank on integrating climate-related objectives into financial market metrics, processes, and regulation. Our mission is to align the financial markets with the goals of the Paris Agreement. The association was founded in 2012 in Paris, and now employs 30 people based in New York, Berlin, London and Geneva. All entities of the group are non-for-profit, the US entity is a 501c3.

Our work is global, both in terms of geography and engaging key actors. Our specificity is to be vertically integrated: we design the public policies, the standards, the data and tools that enable the implementation of our recommendations, and directly provide them for free to financial institutions and regulators. Our team include policy analysts, software engineers, data scientists and business consultants.

2°ii is notably know from having introduced climate-scenario analysis for investment and lending portfolios. Our approach has been adopted and endorsed by authorities (France, Switzerland), financial supervisors (California, Europe) and various investors associations. It is now used by hundreds of financial institutions and the leading financial supervisors.

2°ii research has also triggered the obligation for financial advisors based in Europe to address the 'non-financial' investment objectives of their retail clients. In the next few years, we will invest in the implementation of this reform in Europe and its exportation in other jurisdictions. Our work notably involves policy research, legal analysis, behavioral science research, database and software development.
